




National Voter Registration Day

Step 1: Develop A Plan

- Appoint a point person or team to learn your state's requirements and distribute info to clients
- Contact your local or state election office to:
 - Learn the eligibility rules, address requirements, and identification requirements for your state
 - Determine the process for online and paper form registration, including assisting with and returning completed forms to the election office.
 - Learn the registration deadlines and get started ASAP
- Partner with local organizations that provide voter registration

Step 2: Voter Registration

- Register your client to vote, Be familiar with:
 - With the physical address and mailing address requirements are, allow your clients to use the address of the organization.
 - Know the ID requirements in your state and how that impacts the registration process.
 - Voting rights for those with felony records.
 - Know where the polling locations are .
 - You may be able to use the National Voter Registration Form.
