



Exhibit 1-1: PIT Estimates of People Experiencing Homelessness by Sheltered Status, 2007-2024

Every year, HUNDREDS OF THOUSANDS OF PEOPLE FALL INTO HOMELESSNESS — faster than the homeless service system can help them.



THE RESULT: A CLOGGED SYSTEM THAT CAN'T KEEP UP. People remain homeless not because they're unready, but because housing isn't available.

When housing is affordable, FEWER PEOPLE FALL INTO HOMELESSNESS IN THE FIRST PLACE.



It's not the only solution — but it's the solution that makes all the others possible.

PROPOSED CHANGES TO HUD HOMELESSNESS FUNDING


- Reduction: Proposes reduction in the overall amount of funding available for HUD's Special Needs Programs (including ESG, CoC and HOPWA) of <u>\$532 million</u> from FY25's amount.
- Consolidation: Proposes the consolidation of the Continuum of Care (CoC) Program—along with Housing Opportunities for Persons with AIDS (HOPWA)—into the Emergency Solutions Grants (ESG) program.
- Formulation: It shifts the awarded funds from a competitive application to a formula allocation that does not account for renewal demand; would place thousands of projects and the hundreds of thousands of people they serve at risk.

WHAT WE LOSE IN THIS SHIFT

- Permanent Supportive Housing: 167,000 beds for people with disabling conditions
- Youth Homelessness Demonstration Program: 8 rounds awarded to more than
 120 communities
- Housing Opportunities for People with AIDS: 46,000 Households lose housing/support
- National Homelessness Data Analysis Project: Produces the Annual Homelessness Assessment Report to Congress
- Technical Assistance: 150 Communities
- Homelessness and Crisis Response Backbone
 - CoC Planning
 - Data Collection/HMIS
 - Coordinated Entry
- Emergency Housing Vouchers: 60,000 Households





RURAL AND SUBURBAN AREAS WILL BE HARDEST HIT


FEDERAL DOLLARS ARE CRITICALLY IMPORTANT FOR PSH RESIDENTS NOT LIVING IN CITIES

Homeward & the Greater Richmond Continuum of Care






Homeward was created by community stakeholders in 1998 to serve as the planning and support agency to address homelessness in the Richmond region.

The Greater Richmond Continuum of Care in Virginia includes the City of Richmond, and the counties of Charles City, Chesterfield, Goochland, Hanover (including the town of Ashland), Henrico, New Kent, and Powhatan.

Homeward serves as the Collaborative Applicant for the GRCoC and provides person-centered data collection and service coordination.


Single day winter day count of people in shelters or sleeping outside in the Greater Richmond, VA region, 2009 - 2025

THE PEOPLE SAID: I WANT TO BE TREATED WITH VALUE, DECENCY AND RESPECT

- The people believe in an equal society in which everyone has a home and access to services and freedom to choose.
- The people recognize that bias occurs in the housing system intentionally or unintentionally and that we must act consistently and proactively to identify and remove it.
- The people value the voices, spaces and places of all communities, including those who have or are currently experiencing homelessness with the commitment to seek meaningfully inclusion in all housing.
- The people believe that sustainability in all endeavors enhances our lives across the board that create environments that capitalize on ways to promote and emphasize its value.

THE PEOPLE SAID: INCREASE THE % \$125,000,000 PLANNING GRANT FOR LIVED EXPERIENCE WORK

- Bigger Investment In The Work: That supports talent Lived Experience Leaders Experts and Advisors
- Strengthening Partnerships: 1000's of Members on Continuum of Care Boards Across USA
- Improved Systems: That Will Transform and Produce Innovations around the core principals for the 167,000 Lives In Supportive Housing and how we can safe keep affordable housing
- Better Best Practices: Engage In Performance Expectations to improve the Housing justice Model, in which lived experience leaders, experts and advisors provide a crucial impact in many focus areas
- Financial Support: Lived Experience Leaders, Advisors and Experts need this compensation, they rely it to survive, but they are actively participation in preventing and ending homelessness together with National Partners.

HOW CAN CONGRESS HELP END HOMELESSNESS?

A Budget to Address the Need



OVERVIEW OF FEDERAL BUDGET PROCESS

Phase 1: Congress sets overall spending levels

- President's budget is released with agency specific proposals—usually
- Budget Committees mark up a bill and pass a resolution agreement
- House and Senate set a conference agreement to reconcile their budgets and set
 overall discretionary spending levels

Phase 2: Congress sets HUD funding levels

- Full Appropriations Committee sets funding levels for House and Senates subcommittees on Transportation-Housing and Urban Development
- Subcommittees determine funding levels for programs

Phase 3: Congress Enacts Appropriations Package

- House and Senate mark-ups begin
- House and Senate work out differences for a final funding bill ("conference report")

HOW CONGRESS CAN HELP SOLVE HOMELESSNESS

 The Alliance is recommending that Congress provide HUD's Homeless Assistance Grants account with a \$4.922 billion appropriation in Fy2026-- Increase of \$867 million over FY2025
